Go to https://studentaid.ed.gov/sa/fafsa.

Log in with the student's FSA ID and password.

- If you are a new user filling out the FAFSA for the first time, click "Start Here."
- If you are a returning user, select "Log in." Then, select "Make FAFSA Correction" and click Next.

Select the "Financial Information" section from the menu bar at the top of the page.


- You will be asked if you have completed your 2017 IRS Income Tax Return. You must be able to select "Already Completed" to continue.


